Subject: Setting up of an Empowered Committee for Infrastructure Development

Government has set up a Council for Infrastructure Development (CID) under the chairpersonship of the Hon'ble Chief Minister, with a view to decide on the policy issues pertaining to infrastructural projects, specifically in relation to projects being developed on Public Private Partnership (P.P.P.).

2. With a view to facilitate the functioning of the CID, Government has decided to constitute an Empowered Committee of Infrastructure Development (ECID) is hereby constituted, in supersession of all previous orders in this subject, which shall consist of the following:

3. The ACS/Pr. Secretary/Secretary of the concerned departments whose project is to discussed, may be called as per requirement.

4. The Chairman may invite any other officer to join the deliberations of the Committee.

5. The Empowered Committee may, from time to time, invite other officers, experts and stakeholders concerned for consultation.

6. The Empowered Committee will:

- (1) Formulate/ review/ recommend policy papers and proposals for submission to CID;

- (2) Monitor and follow up on implementation of the decisions of CID; and
 - (3) Undertake such other actions as may be necessary in furtherance of the objectives of CID.
7. The Empowered Committee may be assigned such other tasks by CID as may be considered necessary from time to time.
 8. The Empowered Committee shall meet once every fortnight or as often as may be necessary and will submit a monthly report for consideration of Chief Minister/ CID.
 9. The Empowered Committee will be serviced by the Planning Department. The Department concerned will render necessary assistance to the Committee.
 10. The Planning Department shall be Administrative Department of the Committee.
